ELECTION OF A MEMBER OF PARLIAMENT

for the

STEVENAGE CONSTITUENCY

1. An election is to be held of A MEMBER OF PARLIAMENT for the STEVENAGE CONSTITUENCY.
2. Nomination Papers may be obtained from the Acting Returning Officer, Stevenage Borough Council, Daneshill House, Danestrete, Stevenage, Hertfordshire SG1 1HN who will, at the request of any elector for the said Constituency, prepare for signature a Nomination Paper.
3. Completed Nomination Papers and the prescribed deposit of £500.00 must be delivered to the Acting Returning Officer, Stevenage Borough Council, Daneshill House, Danestrete, Stevenage, Hertfordshire SG1 1HN, from the day following the date of this notice, on Monday to Friday between the hours of 10.00am and 4.00pm, but not later than 4.00pm on Thursday, 11 May 2017. The deposit may be made by legal tender or by means of a banker's draft.
4. If the election is contested, the poll will take place on Thursday, 8 June 2017 between the hours of 7.00am and 10.00pm.
5. New applications to vote by post and requests to cancel or change an existing postal or proxy vote must reach the Electoral Registration Officer at Stevenage Borough Council, Daneshill House, Danestrete, Stevenage, Hertfordshire SG1 1HN by 5.00pm on Tuesday, 23 May 2017, if they are to be effective for this election.
6. New applications to vote by proxy must reach the Electoral Registration Officer at Stevenage Borough Council, Daneshill House, Danestrete, Stevenage, Hertfordshire SG1 1HN by 5.00pm on Wednesday, 31 May 2017, if they are to be effective for this election
7. Applications to vote by emergency proxy on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Stevenage Borough Council, Daneshill House, Danestrete, Stevenage, Hertfordshire SG1 1HN by 5.00pm on Thursday, 8 June 2017, if they are to be effective for this election. The physical incapacity must have occurred after 5.00pm on Wednesday, 31 May 2017. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5.00pm on Wednesday, 31 May 2017.
