


<p>I would like my local Councillor to consider the following request for funding:</p> <p>The Longmeadow Toddler Group is open to as many local mothers as space allows, and meets twice weekly at the Longmeadow Evangelical Church.</p> <p>The paved and grassed outdoor play area for the children abuts directly to the church car park without any physical separation. For greater safety a low fence is needed to ensure children are kept within the play area and to ensure vehicles are prevented from parking on the play area. The play area is supervised at all times when in use by the toddler group.</p> <p>An established and reputable local fencing company (TAE Limited) have provided their lowest quote to supply and erect 26m of 900mm high round top picket fencing with matching gate for this work.</p> <p>The gate shall also allow unimpeded access to the car park from the main church hall.</p>
