<p><b>I would like my local Councillor to consider the following request for funding:</b></p> <p><b>Gardening Project for Dads</b></p> <p>We have asked Dads what they would like to do at the Children's Centre as they are often reluctant to attend some of the services that they see as more female orientated. We also have a growing number of young Dads (under 22) who are keen to get involved at the Centre but have not always engaged well in the past with services. Dads have told us that they would like some sort of gardening project and we would like to link this with our work on the Eat Better, Start Better programme which has just been launched publicly. Dads will grow food such as vegetables and herbs at the centre that can then be used in the cooking sessions with families. This would mean that, for example, a group of Dads could attend the centre weekly to do the sowing, tending etc of some vegetables which are then used as part of a cooking course about healthy eating for the family on a budget. Added to that is the learning for the children and doing something with their parents, whether that is the gardening or the cooking - or both.</p> <p>We will need to purchase plants and seeds, planting boxes, wellington boots, all necessary equipment such as watering cans, hosepipe, netting, trellis. As Bridge Road Children's Centre covers the Woodfield, Old Town and Symonds Green wards, I have approached all councillors in these wards for funding and have received a very positive response. The project as detailed above will be funded jointly by local councillors and County Councillor James Fraser has agreed to fund the purchase of a shed. The cost of a contractor preparing the base and installing the shed is included in the overall cost.</p>
