<p>I would like my local Councillor to consider the following request for funding: <i>(please continue on a separate sheet if necessary)</i></p> <p>Crossroads Care Hertfordshire North provides respite breaks for unpaid Carers of those who are ill, frail or disabled or who have mental health or substance abuse problems. We currently work with over 280 Carers and those they care for in Stevenage. We also run a very popular Day Centre in Roebuck which offers local carers the chance of a break 3 days a week from Wednesday to Friday. Recently we have also set up Monday sessions at the Day Centre with a Carer's café in the morning and a Moving On group in the afternoons.</p> <p>We take a pride in our workforce and our Carer Support Workers (CSWs) are highly trained but we need to ensure that those skills continue to develop to meet the high standards we expect to deliver our valued and flexible service. To keep skills updated each CSW is required to commit to an ongoing training programme. With each mandatory course within the programme costing in the region of £100 per CSW the cost of training each year is very high. We currently have over 35 Carer Support Workers working with clients in Stevenage and are still recruiting to meet demand. We have 17 carers in Stevenage waiting for a break who we will be able to help with this training. Training is essential and your support in training one of our CSWs in this way would make such a difference.</p>
