<p>I would like my local Councillor to consider the following request for funding: Our play association would like to request funding for self build outdoor adventurous play equipment. There are two pieces of equipment that have been identified through consultation with they children who attend the playcentre (we have over 1100 children and young people aged 5-14 years registered to the playsite excluding parents with under 5's)The equipment we would like to build are an obstacle challenge course and a adventure ship. As both pieces will be self build we can adapt the build to suit the funding raised and will be able to add to the build to enhance play opportunities in the future. The estimate of the funding required are £2000 for the ship and £2000 for the obstacle challenge total £4000. We plan to have a couple of community building days involving parents and members of the community who have offered their help and would employ our local carpenter to lead the build as he has a proven track record by building our existing slide, sand play and gardening area. We have applied for £2000 from the Localities budget and have been successful in obtaining £500. From this Years family fun day we raised £400. So funding to date totals £900 leaving a short fall of £3100. As I have already said we can adapt the build to suit the funding we raise and would be able to add to the build in the future should there be a shortfall in the funding.</p>
