<p>I would like my local Councillor to consider the following request for funding: <i>(please continue on a separate sheet if necessary)</i></p> <p>The Irish Network Stevenage was formed in late 2007, in response to the identified need that the level of support required by an ageing Irish population was growing and that a wider network of help was essential to meet the cultural needs of Irish residents within Stevenage. Since its inception in 2007 we have grown from 25 members to our current list of 106. Our regular activities centre around our older people, we organise monthly events, live traditional music, fund raising events, social outings, signposting and in addition to this we produce a regular newsletter. The Irish Network Stevenage is the only organisation dedicated to meeting the needs of the Irish in Stevenage and as a group we are affiliated to the Federation of Irish Groups. Our four themes are; the well-being of Elderly Irish, Cultural interests, Irish language and education, preserving the heritage of Irish history in Stevenage and Promoting Gaelic Games/Sport within Schools.</p> <p>We arrange a Christmas Dinner every year for our members; it is a fantastic event that allows everyone, especially our more vulnerable members, to have a lovely afternoon with friends to celebrate Christmas. Some of our members are away from their families and this is the only Christmas meal they have. With this in mind we would like to apply for some financial assistance from the Locality Budget so we can subsidise this for our members. We have never asked for funds for this before and have always subsidised this event, but we know that many of our members are struggling financially and will not be able to afford to attend this event. We have limited funds and we will be subsidising the Christmas meal but the costs associated to this has increased and our funds are also reducing, therefore we will struggle to provide as much assistance this year as in previous years.</p>
