Stevenage Volunteer Police Cadets (SVPC) is supported by Hertfordshire Police Officers, staff and community partners who volunteer their free time to facilitate young people aged between 13 and 18 years old meeting up and having fun whilst learning skills that will help them to serve their community.</p> <p>SVPC focus on the following 3 areas: -</p> <p>1 - Police &amp; Partnership Inputs; 2 - Volunteering in the Community, &amp; 3 – Recreation/Education (Outdoor activities, sport, social events etc...) Whilst carrying out all of the above, the SVP Cadets have opportunities to gain recognition for Volunteering along with NVQ's and other qualifications such as First Aid that helps them build their CV's for the future. So far, the SVPC have assisted with many community events such as Dogwatch Carnivals, Race for Life, Sonisphere, County SNT Awards and fundraising for charities such as Cancer research, Domestic Violence.
