<p><b>I would like my local Councillor to consider the following request for funding:</b> <i>(please continue on a separate sheet if necessary)</i></p> <p>Community improvement to the Oval shopping precinct. Following a meeting of council officers and local business owners in June 2011, an action plan was drawn up to improve the neglected Oval shopping area; including painting existing steel beams, introducing new litter bins, a new sign and potential improvements we applied for G.A.F funding for new benching to be installed replacing existing tired seating and introducing further seating. The G.A.F funding awarded £2,143 and councillor contributions will add a further £1000 to cover the total cost of four new benches and a relocation of an existing bench.</p> <p>The extra benching follows observations at the precinct during busy shopping times when elderly people have little opportunity to take a rest before returning home, people who wish to eat their fish and chips like to sit down.</p> <p>The venture is supporting local business as well as improving the facilities and impression of this area which is in need of a facelift. The benches will be fully transferable to any regeneration project that may go ahead at a later date and therefore I consider this purchase to be an investment for this area.</p>
