HELP with child care costs

Housing Benefit and Council Tax Support rules include help for people who have to pay child care costs.

If you receive Tax Credits, the child care costs you pay may also be taken into account.

The assistance is in the form of a “disregard” of up to £175.00 per week of earnings per family when child care charges are paid for one child, or up to £300.00 per week, when charges are paid for two or more children.

Who can qualify?

The disregard will apply where a claimant is:

- A lone parent in paid work for more than 16 hours per week.
- A member of a couple, both of whom are in paid work, more than 16 hours per week.
- A member of a couple where one is in paid work for more than 16 hours per week and the other is “incapacitated”.

“Incapacitated” means disabled or blind and getting certain benefits.

What child care costs count?

The disregard applies to children only until the first Monday in September after their 15th birthday (16th birthday if disabled).

The care must be provided by either:-

- A registered childminder.
- A registered nursery.
- For children aged 8 and over, but under 15 (16 if disabled), care provided by a local authority.
- A child care scheme exempt from registration.

How much?

For Housing Benefit and Council Tax Support, average weekly childcare costs are calculated through the year and costs of up to £300.00 per week are “disregarded” from income. The maximum childcare disregard for one child is £175.00 per week.

How to find out if you qualify?

If you receive Housing Benefit or Council Tax Support, contact East Herts Benefit Service **NOW!**

You will be asked to provide proof of the childminder’s registration.

Example 1

Family with one child whose 15th birthday (16th if child is disabled) is on 30 June 2005, relevant child care charges of £170.00 per week are incurred.

A disregard of £170.00 per week applies until 5 September 2005, from 6 September the disregard will no longer apply.

Example 2

Family with two children, aged 14 and 9. Child care costs of £210.00 per child, per week are paid - a total of £420.00 per week.

A disregard of £300.00 per week applies. Note: The maximum disregard applies to the total relevant child care charges incurred, not for each child.

Example 3

Family with two children, aged 10 and 16. Child care charges of £200.00 per week are incurred (£120.00 for the younger child and £80.00 for the older child).

Disregard of £175.00 applies. Relevant childcare charges are incurred for only one child as the second child is not of qualifying age.

What if I do not get Benefit now?

If you do not already receive Housing Benefit or Council Tax Support and you are paying for child care and you think you may qualify, why not apply?
