Location

Stevenage is a large town and borough in Hertfordshire, England, 29 miles north of London. Stevenage is east of junctions 7 and 8 of the A1, between Letchworth Garden City to the north and Welwyn Garden City to the south.

The town centre is undergoing a huge transformation with substantial investment being delivered by the Council. 
