#### 1. Decision

The decision is to appoint Kyle Smart Associates to carry out Architects services for the proposed Local Plan site HO4.

# 2. Reasons for the decision

Following a competitive procurement exercise, Kyle Smart Associates were the successful tenderers, scoring 1<sup>st</sup> on quality, 10<sup>th</sup> on price and 1<sup>st</sup> on social value.

The tender was advertised on the Council's In-tend portal, and was an open procurement so available to the whole market. The opportunity was listed on the 4<sup>th</sup> December 2023, and was available for 44 days. Tenderers all had access to the ITT and Response Document, as well as a detailed specification. The successful contractor will sign up to a standard High Value Services Contract which was also included within the tender.

# 3. Alternative options considered and rejected <sup>2</sup>

The option to not appoint following the procurement was considered, however this was rejected as the successful bidder represents good value for money.
