### 1. Decision

To approve the High Rise Building Safety Resident Engagement Strategy.

### 2. Reasons for the decision

The High Rise Resident Building Safety Engagement strategy has been reviewed at the Executive Housing Working Group meeting held on 10 July. We have made changes where required and as suggested.

The strategy is required by the Building Safety Act 2022 and is pivotal in our approach to keeping our tenants safe and buildings compliant. It will also empower our residents to have a voice in the way the buildings are upgraded and maintained when building safety works are required.

There has been engagement activity held with residents of high rise and other higher risk buildings to help inform the strategy particularly regarding the preferred methods to communicate and engage with them around building safety.

A tenant friendly version will be designed, and a copy sent to all residents of the Council's five High Rise Buildings and published on our website:

Brent Court Harrow Court Hight Croft High Plash The Towers

We will monitor and record all outcomes of resident engagement in accordance with the strategy. The strategy will be reviewed and updated at regular intervals in consultation with residents. It can also be expanded in scope in the future to cover other higher risk buildings as required.
