

## **DECISION RECORD 1**

#### 1. **Decision**

To approve the formation of a Joint Venture Joint Venture to deliver Plot A of the SG1 scheme, in a partnership between Stevenage Borough Council and Mace Developments, and the commencement of the project to deliver a new regeneration project of 261 new homes and commercial space on Plot A of the SG1 scheme.

## 2. Reasons for the decision

- 2.1 In July 2023, Executive agreed to extend the current conditional phase of the Development Agreement between Mace and Stevenage Borough Council and begin the process of establishing a Joint Venture, in order to progress the Stevenage SG1 regeneration programme.
- 2.2 This project is being brought forward, following a challenging economic context. The Covid pandemic (2019) brought wide ranging impacts for the economy and society, and was followed by an inflation and cost of living crisis over two years (2022 2024) that has impacted on the viability of a number of regeneration schemes across the country.
- 2.3 Stevenage Borough Council and Mace Developments have been working together to be able to commence the SG1 regeneration programme. As reported to Executive in July 2023, the agreed strategy is to form a Joint Venture that can deliver Plot A (former Swingate House and car park) of the SG1 scheme, including 261 residential units for private sale and ground floor commercial space.
- 2.4 Since the decision taken to approve the formation of a Joint Venture (July 2023), a significant programme of activity has been underway to bring this forward.

## 3. Alternative options considered and rejected <sup>2</sup>

3.1 Do nothing – This would jeopardise the delivery of the Stevenage regeneration programme that has been established with Mace through a development agreement.
