


Proposed parking controls in Green Street, Ivel Road and Woolners Way

Following various parking complaints and a petition received by the Council from residents of Green Street, Ivel Road and Woolners Way, in February 2025 we contacted in writing all households of the above streets asking if they would be in favor of permit parking controls.

From those who replied to our parking survey, 34 households wanted the Council to formally propose a Residents Parking Permit scheme, and 4 residents were against. A clear majority want the Council's parking team to implement permit parking controls. Therefore, the Council is formally proposing the implementation of a permit controls in Green Street, Ivel Road and part of Woolners Way as shown on the enclosed plan TPE/03/24-8/01.

In the parking survey we asked residents if and what type of resident parking permit scheme the Council should implement to prevent non-resident parking. Their answers to the main questions are highlighted below.





We are now formally proposing permit parking controls for the on-street areas in Green Street, Ivel Road and Woolners Way, from 8.30am to 5.30pm, Monday to Saturday, in order to help residents park near their homes. Only residents will be able to have permits, and they will also be able to get visitor vouchers for their guests. The areas affected are shown on the enclosed plan TPE/03/24-8/01. The

proposed permit prices can be found in Table 1 of this letter. Caring Visitor parking permits are issued free of charge to those eligible and are valid for two years. Residents that are blue badge holders are entitled to a free resident parking permit for their own vehicle. If implemented, these restrictions will not apply to privately owned land such as driveways or garages.

Comments in support of the proposals will also be received during this time.
