THE BOROUGH OF STEVENAGE (PERMIT PARKING) ORDER 2018 (AMENDMENT) ORDER 2020

NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police has made the above named Order under Sections 32, 35, and 45 to 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

This Order has been made in order to reduce congestion and maintain and improve the amenity of the area for residents by making additions and improvements to the existing Permit Parking Area, and will take effect on 1 December 2020.

The effect of the Order is to introduce permit parking controls to Albert Street, Basils Road, part of Church Lane, Grove Road, Southend Close, Stanmore Road, Victoria Close, and part of Walkern Road under the Permit Area Identifier OT, with effect from 8.30am to 5.30pm Monday to Saturday.

The further effect of the Order would be to enable the use of virtual parking permits and visitor vouchers, rather than only allowing physical permits/vouchers to be used; and to make Caring Visitor Parking Permits free of charge, in this area and in the existing Permit Area B.

It is proposed that parking permits will be available for use in vehicles with a maximum authorised mass of up to 3,500KG and which seat fewer than 12 passengers in addition to the driver and that the charges associated with the scheme will be:

This Order has been made in order to reduce congestion and maintain and improve the amenity of the area by allowing short stay customer parking to support businesses and allowing residents to park, while deterring on-street commuter parking, and will take effect on 1 December 2020. The effect of this order is to create new three hour Limited Waiting parking places, no return allowed within four hours, with effect from Monday to Saturday 8.30am-5.30pm at locations near to businesses and local services in Albert Street, Letchmore Road, Sish Lane and Stanmore Road.

The further effect of this order is to create new three hour Limited Waiting parking places, no return allowed within four hours, with effect from Monday to Saturday, 7am-6.30pm at locations in Church Lane, Drapers Way, Primett Road, Stanmore Road and Walkern Road, with an exception for permit holders and their visitors.

THE BOROUGH OF STEVENAGE (OLD TOWN, STEVENAGE) (RESTRICTION OF WAITING) ORDER 2020

NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police has made the above named Order under Sections 1, 2 and 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The Order has been made to facilitate the passage of traffic on the road and improve the amenity of the area by preventing obstructive parking taking place, and will take place on 1 December 2020. The effect of this order is to create new "no waiting at any time" restrictions to prevent potentially obstructive parking from taking place at the junction of Albert Street and Letchmore Road, the eastern end of Drapers Way, on the ninety degree bend of Stanmore Road and at property entrances in Church Lane (almost entirely in place of existing Keep Clear markings) and Walkern Road as set out in the Order and accompanying plans.
