THE BOROUGH OF STEVENAGE (TOWN CENTRE) (OFF-STREET PARKING PLACES)
ORDER 2008 (AMENDMENT) ORDER 2023; AND
THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (DISABLED PERSON'S
PARKING PLACES) ORDER 2023; AND
THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (PROHIBITION OF WAITING,
LOADING OR UNLOADING) ORDER 2023**

NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police has made the above-named Orders under Sections 1, 2, 3, 32-35C, and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

These orders have been made to avoid danger to persons or traffic using the road and prevent the likelihood of any such danger arising; to facilitate the passage of traffic on the road; preserve and improve the amenity of the area; and prevent and relieve the congestion of traffic. The off-street Orders will come into operation on 29 January 2024. The on-street Orders will come into effect on 15 January 2024.

The effects of these orders are:

- to revise the layout of disabled parking bays, pay-by-phone parking bays and no waiting, no loading parking restrictions in Marshgate to correspond with the needs of the updated street layout;
- to bring up to date the area designated as a car park in Marshgate, with appropriate rules for its management; and
- to define the charges for parking in Marshgate Car Park and update the charges for parking in Railway North Car Park as set out below.

Any person wishing to question the validity of this Order or any provision contained within the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to that order, may apply to the High Court for this purpose within six weeks of the date on which the order was made 2 January 2024.
