



**THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (DISABLED PERSON'S PARKING PLACES) ORDER 2021; AND
THE BOROUGH OF STEVENAGE (NEW TOWN CENTRE) (ELECTRIC VEHICLES' PARKING PLACES) ORDER 2021; AND
THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (LOADING ONLY) ORDER 2021; AND
THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (PROHIBITION OF WAITING, LOADING OR UNLOADING) ORDER 2021; AND
THE BOROUGH OF STEVENAGE (MARSHGATE, STEVENAGE) (PAY-BY-PHONE PARKING PLACES) ORDER 2021; AND

NOTICE IS HEREBY GIVEN that the Stevenage Borough Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police has to made the above named Orders under Sections 1, 2, 3, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

These Orders have been made in order to maintain and improve the amenity of the area and to facilitate the passage of traffic on the roads by allowing disabled drivers to park, providing for other parking subject to payment, providing spaces for electric vehicle to be recharged, providing for a loading bay, preventing hazardous or obstructive parking from taking place, and removing parking controls from an area that is to become private land.

The effect of the Orders is to introduce parking restrictions in Marshgate and Swingate, Stevenage as specified in the Schedules to this Notice. The Orders will come into effect on 27 September 2021.

Full details of these proposals are set out in the draft Orders which, together with plans and a statement of reasons for proposing to make the Orders, can be examined during normal opening hours at the Council's offices in Daneshill House. Any person wishing to question the validity of any of these Orders or any provision contained within any of these Orders on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to that order, may apply to the High Court for this purpose within six weeks of the date on which the orders were made 22 September 2021.

Disabled Person's Parking Places (waiting limited to three hours, no return in one hour)

Item number	Name of road	Side of road	Description	Special manner of standing
1	Marshgate	East	From a point 18 metres south of its junction with the southern kerbline of the northern arm of the same street, southwards for a distance of 24.5 metres.	None.
2	Marshgate	West	In its south-western turning head, across its full width, extending from the western extremity eastwards for a distance of 6 metres.	Aligned approximately on an east-west axis in accordance with the bay markings.

1	Marshgate	West	From a point 55 metres south of its junction with the southern kerbline of the northern arm of the same street southwards for a distance of 28.3 metres

1	Marshgate	South	From its junction with the western kerbline of the western arm of the same street westwards for a distance of 12 metres
2	Marshgate	North	From a point opposite a point 9.6 metres west of its junction with the western kerbline of the western arm of the same street westwards for a distance of 2.4 metres
3	Marshgate	West	From its junction with the southern kerbline of the northern arm of the same street southwards for a distance of 3 metres
4	Marshgate	West	From a point 12.5 metres south its junction with the southern kerbline of the northern arm of the same street southwards for a distance of 42.5 metres
5	Marshgate	East	From a point 42.5 metres south its junction with the southern kerbline of the northern arm of the same street southwards for a distance of 7.2 metres
