ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF STEVENAGE (PERMIT PARKING) ORDER 2018 (AMENDMENT) ORDER 2023

The STEVENAGE BOROUGH COUNCIL (hereinafter referred to as “the Council”) pursuant to arrangements made with the County Council of Hertfordshire under Section 19 Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000, in exercise of the powers of the said County Council under Sections 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police, hereby makes the following Order:-

1. This Order may be cited as “The Borough of Stevenage (Permit Parking) Order 2018 (Amendment) Order 2023” and shall come into operation on **DD MMMM 202X**
2. This Order amends the Borough of Stevenage (Permit Parking) Order 2018 (hereinafter referred to as “the Order of 2018” as specified in Articles 3 to 4 of this Order.
3. Schedule One of the Order of 2018 shall be amended to include Items 10 and 11 as follows:

Item number	Name of road	Side of road	Description	Permit Area Identifier	Days of operation	Hours of operation
10	North Road	East Side	In Layby: from a point 28.5 metres south of junction with Whitney Drive southwards for 26 metres	B	Monday to Friday, excluding Bank Holidays	8.30am to 5.30pm
11	North Road	East Side	In layby: from a point 45 metres north of junction with Burymead northwards for 40 metres	B	Monday to Friday, excluding Bank Holidays	8.30am to 5.30pm

4. Schedule Two of the Order of 2018 shall be amended to include Item 17 as follows:

Item number	Name of road	Properties within road	Maximum number of Resident Parking Permits per property	Maximum number of Caring Visitor Parking Permits per property	Maximum number of Business Parking Permits per property	Maximum number of Resident's Visitor Parking Vouchers per property	Permit Area Identifier
17	North Road	Nos 7, 7A, 11, 13, 15 and 17 North Road	4 at any given time	2 at any given time	0	12 sets of 20 vouchers between 1 April of one year and 31 March of the next	B

5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
