Meetings were held with the following individuals and organisations, as set out below, and outcomes have been included as appropriate.

Anglian Water	22 April 2016	Ongoing - MoU being finalised.
Aston PC	21 April 2016	Discussed objections made by the Parish Council. No agreement reached.
Bellway/Miller	27 April 2016	Considered objections raised by other parties to the North Stevenage site. Discussed objections made by Bellway/Miller to site specific requirements. Ongoing discussions will continue be held via formal pre-app meetings. A PPA is currently being finalised.
Black Rock/Wyevale	5 July 2016	Objection to G&T site discussed, supportive of allocation of their site. Black Rock/Wyvale to consider SBC's position and decide whether they wish to pursue their objection.
Campaign for the Protection of Rural England	17 Aug 2016	SBC gave further explanation and reference to the Green Belt and Housing Options Technical papers. Likely to still object.
Central Beds	17 Feb and 16 May 2016	Discussions are ongoing regarding allocation of employment land at Biggleswade. A MoU is being drafted.
Cygnets Health Care	1 July 2016	Objection to G&T site discussed. Cygnets Health Care to review Green Belt evidence and consider their position.
Datchworth PC	10 May 2016	Discussed objections made by the Parish Council. No agreement reached.
East Herts District Council	20 April 2016	MoU signed (ED104)
Environment Agency	20 May 2016	Addressed all concerns - MoU signed (ED101)
Friends of Forster Country	24 March 2016	Discussed objections. No agreement reached.
Graveley PC	9 May 2016	Discussed objections made by the Parish Council. No agreement reached.
Home Builders Federation	8 July 2016	Discussed HBF consultation response. HBF are considering position in light of Stevenage Response to HBF (ED105)
HCC Education	15 July 2016	Content with primary school provision. MoU signed 11.07.2016. (ED103) Subsequently, agreement reached on approach to secondary school provision.

HCC Health	18 April 2016	Supportive representations and proposed an extension of the takeaway ban to cover all of the town's neighbourhood centres. HCC confirmed their support for Policy TC9 and for SBC in preparing a technical paper. MoU signed 11.07.2016. (ED103)
HCC Highways	25 Feb 2016	Results of modelling will be fed back into the Plan at Examination stage. MoU signed 11.07.2016. (ED103)
HCC Highways	3 May 2016	Updates made to IDP.
HCC Minerals	2 March 2016	Addressed concerns regarding assessment of minerals reserves in South Stevenage. MoU signed 11.07.2016. (ED103)
HCC Gypsies and Traveller Unit	15 April 2016	Support allocation at HO12. MoU signed. (ED103)
Highways England	2 March 2016	New modelling being undertaken by HCC, liaising with Highways England, should address modelling concerns.
Historic England/Bellway and Miller	19 May 2016	Joint meeting with North Stevenage developers and Historic England. No agreement reached. Historic England confirmed verbally they did not consider the proposal to be of 'substantial harm'.
Homes and Communities Agency	24 March 2016	Telephone conversation confirmed their support of North Road employment allocation.
Homes and Communities Agency	12 July 2016	Letter sent to formally confirm the HCA's support for an employment allocation on their North Road site.
RPF Developments/Iceni	11 May 2016	Support for allocation. Discussed site specific issues including flooding, aggregates and highways. Objections to self-build and affordable homes requirements were not resolved.
Legal and General	29 April 2016	Support for allocation. Discussed the potential for some minor changes to policy wording to resolve the objections raised. Potential amendments have since been agreed by both SBC and L&G.
National Custom and Self-Build Association	11 May 2016	Discussion held to try and further understand the evidence behind the objections raised and the higher target proposed. Further evidence work being carried out by SBC. No change to the Local Plan proposed.

Natural England	23 March 2016	Addressed all concerns and amended SA and AA as appropriate - MoU signed (ED102)
NHS East and North Herts Clinical Commissioning Group	18 May 2016	Updates made to IDP.
North Herts District Council	4 Feb 2016	Ongoing - MoU being worked up
NHS East and North Herts Trust	19 April 2016 and 29 April 2016	Discussed consultation response. No agreement reached. Ongoing work to attempt to bring the NHS Trust and Stevenage Sports Club Ltd. together via a joint meeting to determine whether any compromise can be made between the two parties. SBC will facilitate if necessary.
Origin Housing	29 April 2016	Discussed consultation response. No agreement reached.
Peter Everest	2 Feb 2016	Clarified retail elements of the Town Centre policies. Supportive of Policies and approach.
St Albans District Council	22 Feb 2016	Late representation received from St Albans; that the plan is in accord with the Duty to Cooperate, procedural and legal requirements and soundness, 22.02.2016.
Stephen McPartland	17 May 2016	Detailed discussion of concerns. Unable to agree a compromise.
Stevenage Sports Club	13 April 2016	SSC confirmed they have a legally binding deal with a developer and have never received an offer to purchase their land from the NHS Trust. SBC encouraged SSC to resolve relocation issues with NHDC. Ongoing work to attempt to bring SSC and NHS Trust together via a joint meeting to determine whether any compromise can be made between the two parties. SBC will facilitate if necessary.
Thames Water	22 April 2016	Ongoing - MoU being finalised.
Welwyn Hatfield Borough Council	19 April 2016	Accepted an assurance that there was no intention to draw trade from Welwyn Garden City. WHBC unwilling to provide Employment for SBC. MoU being finalised.
West of Stevenage Developers	10 May 2016	Meetings with Permisson, to further explain policies. Discussions with landowners' agents to explain SBC viability modelling. SBC willing to consider CPO if necessary. No agreement reached at this time.

Wymondley PC	22 April 2016	Discussed objections made by the Parish Council. No agreement reached.
