### APPENDIX A – 2014 Open Space Review: Dataset compared with 2006 (at 9 April 2014)

#### The original PMP spreadsheet

The electronic spreadsheet contains 653 entries (including 4 with no area cited – nos. 674-677). The electronic spreadsheet is produced in hard copy at Appendix M of the PMP Report.

#### **Duplications and double counting**

Ten sites are duplicated, with site Fairlands Valley Park (site no. 6) duplicated twice (other sites duplicated are nos. 7, 70, 126, 131, 168, 221, 222, 233, 365); hence, there are 642 different sites.

Six of those are double counted within the spreadsheet; the remainder are apportioned correctly between two neighbourhood areas, and so are not double counted.

The six double counted sites are as follows. On the whole, a small element of each site crosses into the neighbourhood area shown below in square brackets, but the whole area is attributed to both neighbourhood areas:

It follows that amenity greenspace in Chells, Shephall and St Nicholas, and outdoor sports space in Bedwell, Old Stevenage and St Nicholas, runs the risk of being skewed by this double counting. The standards derived for the Borough through the PMP study are set out at Appendix J. Appendix J contains different total areas for each open space type within the neighbourhood areas than set out in Appendix M.

Looking at differences between the site list at Appendix M and the standards at Appendix J it seems as though this double counting was **not** carried into the final standards and do not skew the figures. This is not definitive, however, as no statement is made within the report, and discrepancies remain.

It should also be noted that Pear Tree Park (3) is recorded in Appendix M as 114 ha, but this error is clearly not carried through to Appendix J (where there is a difference of over 106 ha). This suggests that Pear Tree Park should have a size of 7.9 ha in Appendix M. It is assumed that this is an error, but again it is important to emphasise that this does not carry through the standards in Appendix J.

### The 2014 SBC review

Within the SBC review spreadsheet, 186 sites were deleted. However:

- site 270 Roebuck Amenity Greenspace was deleted twice (185)
- site 185 Broxdell Allotments was deleted despite not appearing in the original PMP list. Site 184 Broxdell Allotments was in the original list, has the same site size and was reviewed, meaning there's probably some double counting in the 'deleted' list – 185 has therefore been ignored for now (184)
- site 281 *Skipton Close D* was neither reviewed or deleted, but does not appear in the GIS and is therefore assumed to be deleted (185).

The net number of deletions is therefore 185.

The two green corridor sites have been removed from the site review. A further 54 sites have been added. The total number of sites within the review is therefore 505.

The majority of the difference between F and G is accounted for by the correction to Pear Tree Park. Therefore, the review concludes that there is a total of 505 sites within the open space categories, covering 560.17 ha.

# **Natural England**

- recommend that, as part of the review, the Council ensure that any assessment of open spaces includes designated sites and landscapes;
- Green infrastructure (GI) is a strategically planned and delivered network of high quality green spaces and other environmental features. It should be designed and managed as a multifunctional resource capable of delivering a wide range of environmental and quality of life benefits for local communities. GI includes parks, open spaces, playing fields, woodlands, allotments and private gardens;
- green infrastructure should be provided as an integral part of all new development, alongside other infrastructure such as utilities and transport networks.

# **Environment Agency**

- advocate an increase in natural green space and ask that river corridors are specifically represented as areas to protect and enhance as part of any strategy;
- encourage the increase in open space for both amenity and habitat benefits;
- the GI network should provide multiple benefits and help to:
  - manage flood risk and improve water quality (through surfaces that enable water infiltration, conveyance, storage and interception, advocating Sustainable Drainage Systems (SuDS) which

can serve a dual purpose of providing habitat and amenity space whilst providing flood risk and water quality benefits;

- respond to climate change (connecting habitats, allowing wildlife migration and adaptation) and manage flood risk;
- enhance and conserve biodiversity (through habitat provision and protection)
- increase recreation, well-being, quality of life and community interaction (through the provision of spaces that encourage exercise, relaxation, congregation and education).
- note that the Hertfordshire Strategic GI Plan (2011) identified that greenspace availability in Stevenage is deficient when assessed using the Natural England Access to Natural Greenspace standards (ANGSt). They encourage the Council to look to utilising river corridors to support the creation of strategic links and routes between key areas and greenspace and the informal opportunities in the wider area. They particularly point to:
  - areas of flood plain in currently undeveloped areas of Stevenage (specifically Bragbury End) which should be safeguarded against development to ensure that it continues to provide valuable GI functions;
  - Stevenage Brook, which presents a great opportunity to improve provision for local people;
  - opportunities to create links to and contribute to the improvements of the River Beane.

#### Herts and Middlesex Wildlife Trust

- 279 households and 557 individuals in Stevenage Borough are members of HMWT;
- Ridlin's Mire Nature Reserve is the only HMWT nature reserve within the Council's boundaries, but Pryor's Wood Nature Reserve (off Gresley Way, and just in North Hertfordshire District) will be used and valued by Stevenage residents for wildlife and recreation;
- parks, gardens and natural open spaces are of most concern to the Trust. Natural greenspaces (including Local Wildlife Sites and nature reserves) are core areas in the ecological network of Stevenage, and should be protected and appropriately managed to maintain and enhance their biodiversity value. Parks and gardens can also offer important habitat and improve connectivity;
- open spaces are important in providing habitat for wildlife and creating links to enable wildlife to move through the town;
- road verges, hedgerows and other 'incidental' green areas can also offer opportunities to improve wildlife habitat;
- it is important to keep in mind that the various functions served by open space are not mutually exclusive. With appropriate management, open spaces deliver multiple benefits simultaneously, e.g. reducing air pollution; reducing surface water flood risk; water purification; shade and local cooling; biodiversity; amenity; recreation, outdoor and natural play; improved health and wellbeing; volunteering opportunities. The Council should take an integrated approach to planning for its green spaces to maximise the overall benefit for the community;
- other green spaces and small habitat areas outside the defined typographies are equally important elements of the town's ecological network: e.g. hedgerows, road-side verges, railway embankments etc.;
- Stevenage BAP includes an objective, 'to manage Stevenage's ancient hedgerows to produce a diverse structure and to ensure their survival for the benefit of wildlife and local residents'. HMWT strongly encourages the Council to put in place appropriate management of its old hedgerows to deliver against this objective;

- in view of the impressive results for biodiversity, HMWT strongly encourages the Council to continue and expand the road-side verges work that was trialled under Wild Stevenage project;
- environmental sustainability and sustainable travel is supported by HMWT. The Council should look to improve access to all types of open space by foot and bicycle, and to ensure that more significant green spaces are served by good, reliable bus services for people living further away. Sustainable modes of travel should be promoted and incentivised, if appropriate. It is nevertheless important to provide some parking, including spaces for disabled people;
- The Council should continue to work on delivering the actions within the BAP;
- The Council should aim to meet the Natural England Accessible Natural Green Space Standard (ANGSt).

# **CPRE Herts**

- the 'entire green network' includes the farmland and woodland within the Borough, but this 'urban fringe' seems to be excluded from the review;
- the Council needs to address the relationship between strategy for open spaces and strategy for other land uses within the Borough, rather than considering each in isolation
- given the intense pressure from within Stevenage for various forms of development, including housing, CPRE Hertfordshire would expect the open space strategy to be reviewed to reflect those pressures;
- consider that green belt open space within the Borough should normally be protected from inappropriate development;
- there is no 'in principle' objection to provision of a wide range of leisure and recreation uses in the green belt to replace land used for other essential development within the town, subject of course to avoiding adverse impact on openness





## **Structurally Important Routes**

The following roads are important in the structural character of the town. They all have wide road verges for much of their length, which is a feature of the town from its inception. Whilst this open space has very little recreational function and generally operates on a visual level (as opposed to being managed actively for, say, its biodiversity potential) it is nonetheless important to recognise its presence and give weight to its role.

What has emerged is the variety of standards that local authorities set for both the provision and the access to that provision (red text denotes a less generous standard then Stevenage; green text a more generous standard). On the whole Stevenage's standards sit between the most and the least generous standards.

\* Stevenage is the only authority in the group that has a children's play space standard based on number of play areas rather than area.

#### **APPENDIX L: Contemporary Public Spaces**

There are many examples of recently designed and delivered town centre public spaces that might provide inspiration and guidance for civic spaces within Stevenage. The following are provided as a starting point.

#### Old Market Square, Nottingham

Rejuvenation of a major central public square in the city to incorporate civic events and provide a focus for the central area.

#### Exchange Square, Manchester

One of a number of new squares and meeting places coming out of the 1996 bomb. Provides an intimate urban space in the main shopping with a backdrop of Victorian buildings and modern retail development.

#### Bermondsey Square, Southwark

Small scale square provided with residential, retail and leisure development designed around archaeological remains and the need to host a regular antiques market. Celebrated square which has won London's best public space award.

#### Town Square, Barking

Another small scale square that provides a walking route between Barking town centre and the Abbey and provides a setting for a new library and the historic town hall building. Contains landscaping and public art.

#### Quayhead Square, Worcester

Intimate public space providing seating, water fountains and event space in a historic riverside setting.

#### Blue Carpet Square, Newcastle

Art-inspired public space adjacent to an art gallery, designed by Thomas Heatherwick in 2002.

#### New Road, Brighton

Public realm interventions on a busy street in Brighton to incorporate shared spaces and allow for better public movement.

#### Wharf Green, Swindon

Intervention in an overlooked town centre space to provide an events space and focus for the town centre. Introduces seating and sculptural elements and a 'big screen'.

#### Castle Square, Caernarfon

Public ream interventions in a well-defined town square to enable events by providing shared spaces in a clean and simple design.

Pedestrian Heart, Darlington

Major investment in the public areas of Darlington town centre to place the emphasis on the pedestrian. Finished with attention to the quality of materials.

#### St George's Square, Luton

Major town centre square on the edge of Luton's main shopping area aiming to provide a focus and destination around Luton's main leisure and civic amenities.

#### Cathedral Square, Peterborough

Public realm interventions in Peterborough city centre introducing high quality materials and fountains to alter the perception of the space.

#### Chavasse Park, Liverpool

Reworking of a left over space between the docks and the city centre in Liverpool to provide an urban green park on a complex site adjacent to the Liverpool One retail development.

#### **APPENDIX M: Local Wildlife Sites**

The following sites are identified as Local Wildlife Sites. Most of these sites are identified in the open space strategy review, and most fall within the natural and semi-natural typology. They are afforded protection as sites of substantive nature conservation value. Their protection is assured through the planning system and this protection goes some way to addressing the duty upon local authorities to have regard to the conservation of biodiversity set out in the Natural Environment and Rural Communities Act 2006. The Local Plan reference relates to the site reference under policy EN17 of the 2004 adopted plan. The sites at Whomerley Wood roadside verge and Barnwell School were designated after the plan was adopted.

The sites shaded in grey are not identified in the open space strategy (for the reasons given) and two sites have been deselected.
